EVENTS CORNER: EXPERT LECTURE, MOTILALNEHRU CHAIR

On 07th November 2024, the Moti Lal Nehru Chair, School of Legal Studies at K. R. Mangalam University organized a special lecture on "Regulation of Artificial Intelligence and Data Protection", aiming to provide students with an in-depth understanding of the evolving legal landscape surrounding AI governance and data privacy. The lecture focused on the intersection of technology and law, addressing key concerns such as ethical AI deployment, accountability, privacy safeguards, and compliance with emerging regulatory frameworks. The primary objective of the lecture was to familiarize students with the legal challenges posed by AI advancements, the necessity of robust data protection laws, and the global best practices shaping AI governance. Through an engaging discussion, the speaker elaborated on critical legislative measures, including the role of GDPR, India's Digital Personal Data Protection Act, and international AI ethics guidelines. The session also explored case studies highlighting Al-related data breaches, bias in AI algorithms, and regulatory responses from different jurisdictions. The outcome of the lecture was a heightened awareness among students regarding the legal implications of Al-driven decision-making, the significance of ethical Al practices, and the importance of balancing innovation with


